4. Precautions when Applying

- ① To apply Foreign students must have a "Student" visa. International students whose period of stay expires before October 1, 2024, must renew their period of stay before moving in.
- ⁽²⁾ Newly arrived self-supporting (privately-financed) students are required to attach a copy of their Admission Letter or Certificate of Acceptance and also Certificate of Eligibility or Application Receipt.
- ③ Foreign students who receive more than 147,000 yen per month as their staying expense (in the form of either "salary" or "scholarship money") from various organizations, are not allowed to apply for the International House. *The amount of "147,000 yen per month" is equivalent to a monthly salary of a Japanese government-funded graduate-level foreign student.
- (4) <u>Since Japanese government scholarship students (graduate-level) receive a monthly salary of about 147,000 yen, they</u> <u>must move into a couple room in principle, and if the applicant has a child they should apply for a family room.</u>
- (5) <u>Application for International House will not be accepted in the following circumstances</u>. Note that your stay in the

International House as a Japanese Language and Culture student or as an Exchange student is not counted as your Residence history.

- Those who have lived alone in a single room, a couple room, or a family room for 12 months or more in total.
- Those who have lived with a family member in a couple room or a family room for a total of 36 months or more.
- (48 months or more in total for doctoral students majoring in medicine or veterinary science) (including the history of the family member's stay).

⁽⁶⁾ Foreign student who are planning to take a leave of absence from the University are not allowed to apply for the International House.

- ⑦ If the applicant plans to live with their family member, the visa status of the applicant's family member must be either a <u>"Dependent" or a "Student" visa</u>. The holders of "Cultural Activities," "Short-term stay," "Researcher" or another status of Residence (VISA) that qualifies for a working permit are not allowed to reside in the International House. In addition, the parents and siblings of the applicant are not allowed to live as an accompanying family in the International House.
- ⑧ In case of a married couple, the residence history will be determined by the one who has the longest residence history.
- (9) International students who have a child, should apply for a family room.
- 1 In case one or both in a couple are international researchers, they must apply for International House C.
- ① Those who own a car are required to submit a copy of their "Driver's License" and "Optional Insurance (Auto Insurance Policy)." *Students who will park at the International House should have a Japanese Driver's license.
- Permission of residence could be invalidated if the approved student did not move into the International House within 10 days from the designated starting day of residence.
- (3) Utility costs are actual costs and occur from the first day of the permitted residence period.
- (4) All residents are required to have the National Healthcare Insurance in Japan to live in the International House.
- (5) A resident who has been ordered to leave the International House, or has received a warning from the Director of the International House before, cannot apply again.
- ⁽¹⁶⁾ If the application form contains false information, the given permission of residence of the applicant will be immediately invalidated and their application will be never accepted even in the future.
- 5. Director of the International House can withdraw the permission of residence and can order the resident to leave, should they fall into the following category:
 - (1) Those who could not meet the requirements for residence one month after moving into the International House.
 - (2) Those who neglect to pay despite being reminded of the rent, deposit and utility bills, etc.
 - (3) Those who have seriously violated the rules of the International House during their stay.
 - (4) Those who are deemed to be unsuitable to lead a dormitory lifestyle due to health reasons.
 - (5) Any other cases that the presence of the resident seriously hampers administration and operation of the International House.
